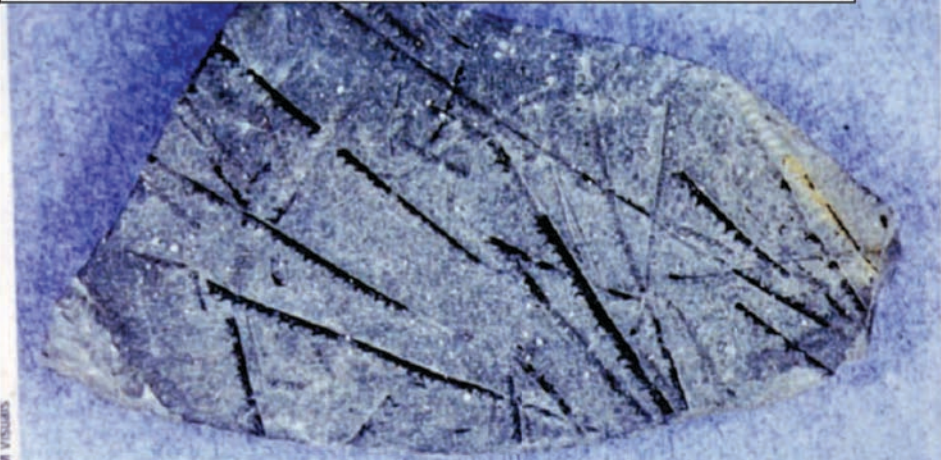

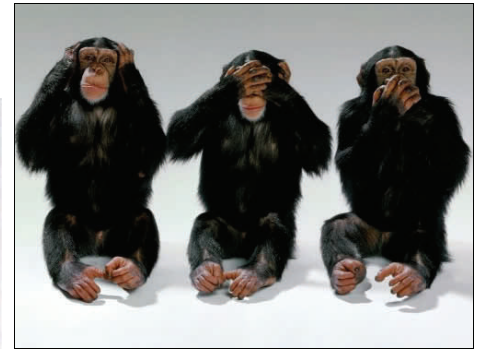

Evolution of Amphibians

The first group of vertebrates to live on land were the amphibians, which appeared about 370 million years ago. Amphibians probably evolved from a group of bony fishes called lobe-finned fishes. As shown in Figure 8, the pattern of bones in an amphibian's limbs bears a strong resemblance to that of a lobe-finned fish. While several species of lobe-finned fishes exist today, those species ancestral to amphibians are extinct.

The "Age of Amphibians"

Although amphibians first appeared in the Devonian period, they increased greatly in numbers during the Carboniferous period. During this time, which began what biologists call the "age of amphibians," the number of amphibian families increased from 14 to about 34. (Recall that a family is a taxonomic category composed of one or more genera.) By the late Carboniferous period, much of what was to become North America was covered by low-lying tropical swamplands. Amphibians thrived in this moist environment, sharing it with early reptiles.

In the Permian period that followed, amphibians reached their greatest diversity, increasing to 40 families. In the early Permian period, a remarkable change occurred among amphibians—many of them began to leave the marshes for dry uplands. By the middle Permian, 60 percent of all amphibian species were living in dry environments. *Eryops*, illustrated in Figure 9, was typical of amphibians of this period and was well adapted for life on land.

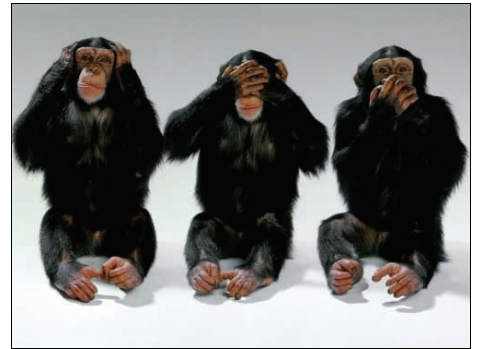
Lobe-Finned Bony Fishes

Only seven species of lobe-finned fishes survive today. One species is the coelacanth (*SEE lah kanth*), shown in **Figure 10**, and the other six species are all lungfishes. The lobe-finned fishes have paired fins that are structurally very different from the fins of ray-finned fishes. In many lobe-finned fishes, each fin consists of a long, fleshy, muscular lobe that is supported by a central core of bones. These bones are connected by joints, like the joints between the bones in your hand. Bony rays are found only at the tips of each lobed fin. Muscles within each lobe can move the bony rays independently of each other.

Scientists have debated whether the direct ancestor of amphibians was a coelacanth or a lungfish. However, recent evidence has led biologists to believe that it was neither. The ancestor of the amphibians most likely was a third type of lobe-finned fish that is now extinct.

Soft Tissue Discovered in Bone of a Dinosaur

Intact after 70 million years, bits of a *T. rex*'s hind leg startle and intrigue researchers.

In bone blasted from Montana sandstone, fossil hunters for the first time have discovered the microscopic soft tissue of a *Tyrannosaurus rex*, preserved almost unaltered inside a bone since the dinosaur died 70 million years ago, scientists announced Thursday.

Scientists at North Carolina State University and at Montana State University's Museum of the Rockies in Bozeman found brownish oblong cells, elastic threads of veins and pliable dabs of red bone marrow in the core of a stout hind leg, the researchers reported in the journal *Science*.

The translucent vessels were so elastic that when one was stretched out and then released, it snapped back like a rubber band.

"To my knowledge, preservation to this extent has not been noted in dinosaurs before," said Mary H. Schweitzer, a paleontologist at North Carolina State University in Raleigh.

"The tissues are still soft," said Schweitzer, who led the research team. "The microstructures that look like cells are preserved in every way."

In Germany, France, the British Isles, Nova Scotia, California, and several eastern states, fossils that extend through several layers of sedimentary rock have been found. These are called polystrate* (PAHL ee STRATE) fossils. They are usually tree trunks in an upright or somewhat slanted position. Polystrate fossils furnish clear-cut evidence that sediment was deposited rapidly, as in a flood. If the rock layers surrounding the fossils had formed at the slow rate that evolutionists assumed as they constructed the geologic time scale, the trees would have decayed or fallen rather than fossilized.

One type of polystrate fossil in California is especially interesting. Near Santa Barbara, fish fossils extend through several layers of algae fossils. Evolutionists calculate that each algae layer took hundreds or thousands of years to form. That would mean that the head and tail of the same fish were buried several thousands of years apart! Clearly the beds must have formed rapidly around the fish, not slowly. The most remarkable find was a polystrate whale fossil extending through many layers and many thousand

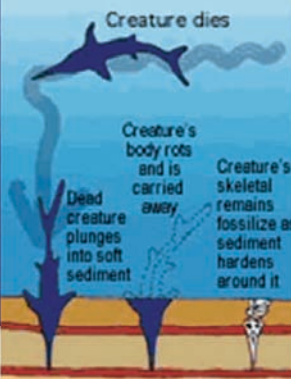

AROUND THE WORLD

They are rare. They are irrelevant. A quick check of photos below from his 30 years around the globe will help you evaluate such claims.

Tennessee USA

20 Bob Powell, USA, excavates the trunk of a huge fossil tassel fern on the border of Tennessee and Kentucky.

21 Such fossils show stem markings similar to modern diminutive tassel ferns, but the fossils were giants. Such change is the opposite of evolution.

Nova Scotia Canada

22 Many excursions were made to Joggins Nova Scotia Canada, where founding father of uniformitarian geology - Charles Lyell - also observed polystrate trees.

23 Excavating below these trees, you notice that the rocks are often also polystrate (Canadian 25c coin for scale). They do not disturb strata they pass through. Modern plant roots distort any strata they penetrate.

Because of the varying fossil layers around it, orthodox geology interprets this tree as standing while many environments (marine, terrestrial etc) buried it over vast periods of time - an obvious impossibility. **25** This problem exists for every polystrate, including the fossil tree at above.

26 Mark Hamies and team give indication of the size of fossil pine trees, passing through many sandstone and siltstone layers in coal seams near Newcastle, Australia.

Queensland Australia

27 Back to Queensland Australia, where Dr. Allen Hall points to a polystrate tree in sandstone near the little known Town of 1770 (Captain Cook fame). **28** For those who want to claim that polystrate fossil trees grew where they are found, this little beauty (discovered by John Mackay Redhead NSW) should help the argument. It is snapped in two and buried with the break still preserved.

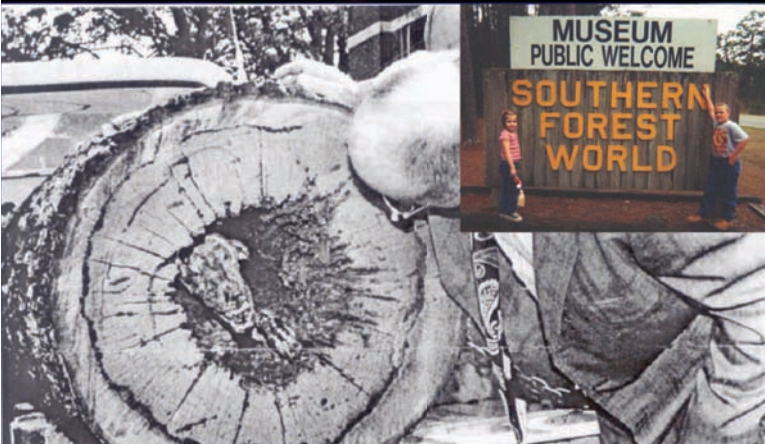

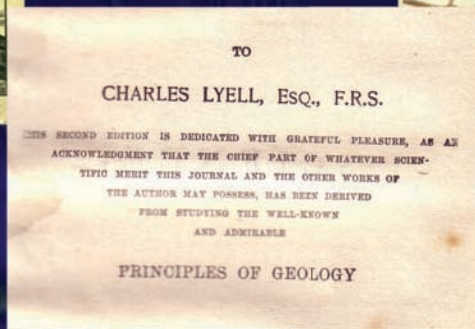
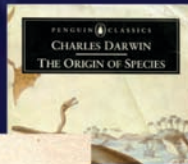
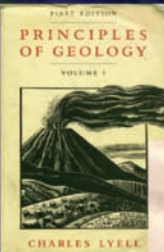
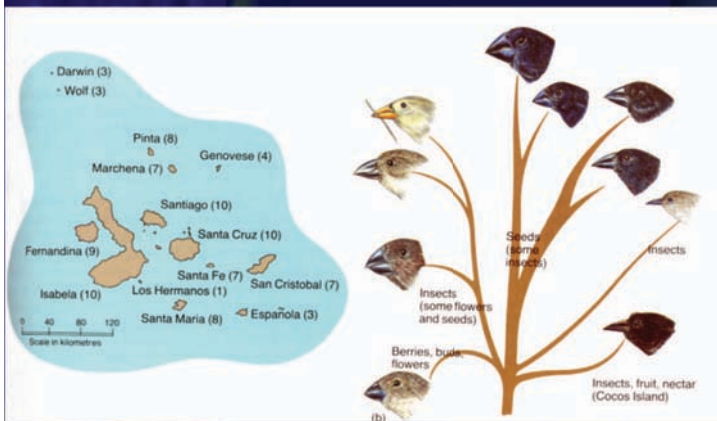
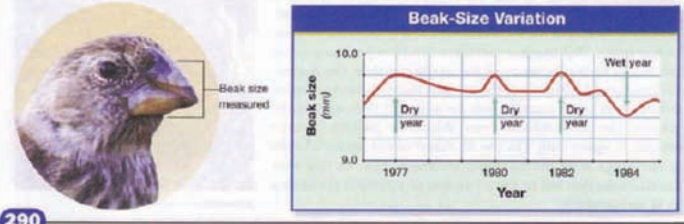


Figure 13 Natural selection in finches

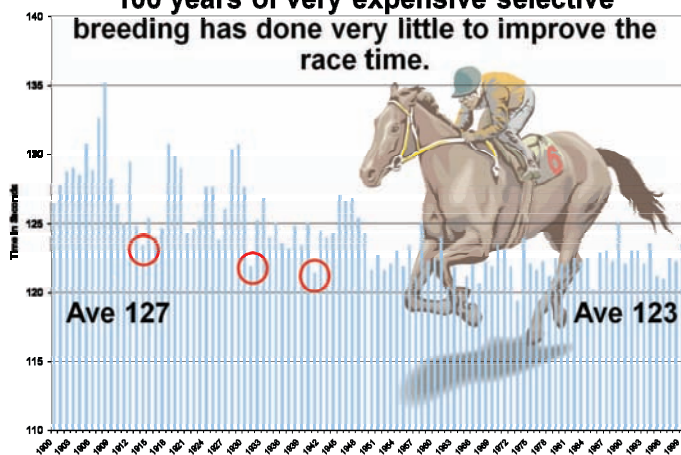
Figure 17.13 A mixed herd of zebroids and horses.

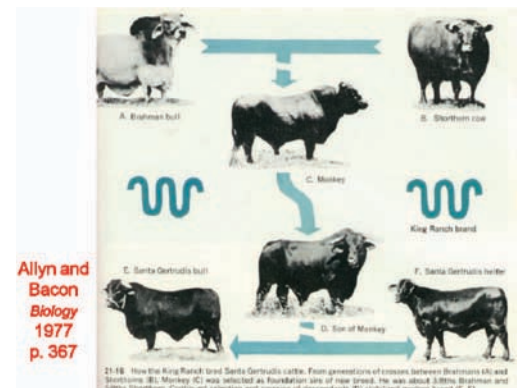

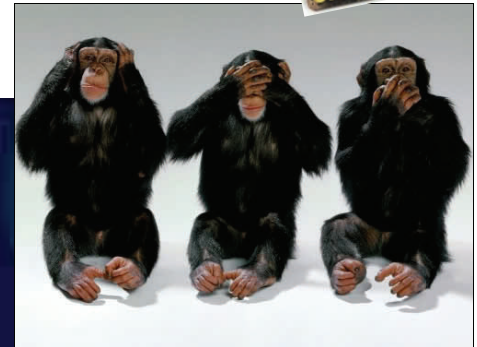

Don't bacteria become resistant to drugs? To advance their view, evolutionists have long pointed to mutations with beneficial effects. The most common example given: mutations sometimes make bacteria resistant to antibiotics (germ-killing drugs).

And so, the argument goes, "If mutations can make bacteria stronger, they must be able to do the same for other creatures." Dr. Spetner points out that this is based on a misunderstanding, for the mutations that cause antibiotic resistance still involve information loss.

Dr. Lee Spetner, who taught information theory for a decade at Johns Hopkins University and the Weizman Institute, spent years studying mutations. He has written an important new book, *Not by Chance: Shattering the Modern Theory of Evolution*. In it, he writes: "In all the reading I've done in the life-sciences literature, I've never found a mutation that added information. . . . All point mutations that have been studied on the molecular level turn out to reduce the genetic information and not increase it." For example, to destroy a bacterium, the antibiotic streptomycin **attaches** to a part of the bacterial cell called **ribosomes**. Mutations sometimes cause a **structural deformity in ribosomes**. Since the antibiotic cannot connect with the misshapen ribosome, the bacterium is resistant.

But even though this mutation turns out to be beneficial, (for the moment) it still constitutes a **loss of genetic information, not a gain**. **No "evolution" has taken place; the bacteria are not "stronger."** In fact, under normal conditions, with no antibiotic present, they are weaker than their nonmutated cousins.

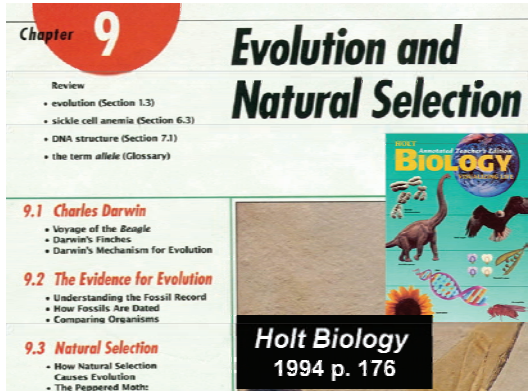

Evolution in Action

Since Darwin published his book, scientists have observed many examples of evolution in action. In a 1977 study of the finches on Daphne Major, one of the Galapagos Islands, scientists observed that beak size could change very quickly by natural selection. That year, little rain fell on the island—only 25 millimeters instead of the usual 130 millimeters or so. Because of the lack of rain, many plants died. Fewer of the seeds that the finches usually ate were available. Instead, the birds had to eat large seeds that were enclosed in tough, thorny seed pods.

Finches with larger and stronger beaks were better able to open the tough pods than were finches with smaller, weaker beaks. Many of the finches with smaller beaks did not survive the drought. The next year, more finches on the island had larger and stronger beaks. Evolution by natural selection had occurred in just one year.

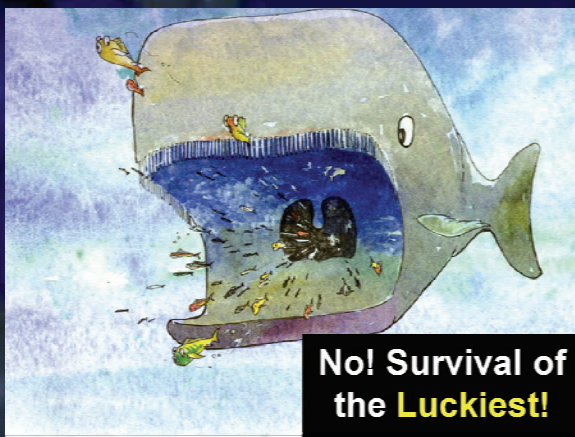

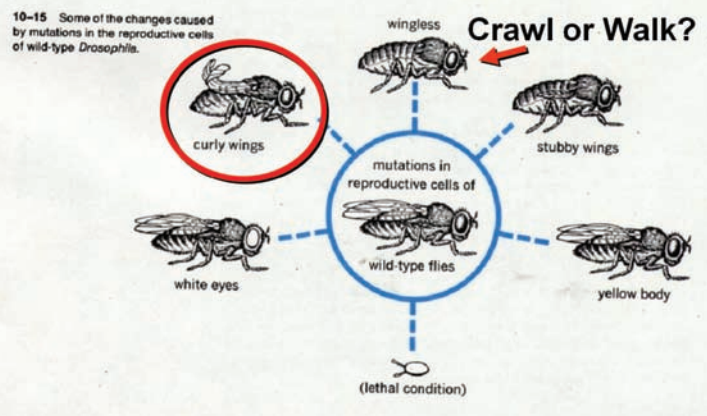

- 3) Kettlewell's results have not been replicated in later studies.
- 4) The shift in moth population did occur but took place well before new lichens grew on polluted trees. A parallel shift in moth population occurred in U.S. industrial areas but there was no change in lichens. (Ref. peppered moth, Natural Selection, Kettlewell)

Should basic and politicians may have their doubts about the theory of evolution, but one in the natural world Darwin keeps making heads down. A study in the latest issue shows that natural selection can produce organisms faster than even some distant evolutionary might have predicted. The clock on this experiment started ticking sometime in 1978, probably when a ship carrying fruit or vegetables from Europe docked in the Pacific Northwest. A few *Drosophila* made it ashore—tiny fruit flies that originate near India in the New World. Since then the flies have been more than British, multiplying and spreading north beyond Vancouver, British Columbia, and now all the way to Los Angeles, in some places steadily driving out native fruit flies. Finding similar new lines, they have evolved a pattern of size differences that mirrors the pattern in their European forebears, which range from Norway to Spain. Just as in Europe, female flies at the northern end of the range have wings about 4 percent longer than those in the south. In Iceland, Darwinian fact-finding, something the new treatment—probably non-persistent—can be used to the size variations, say the researchers, who used wing length as a proxy for body size. No one knows why taller flies are better adapted to the cold, however. A study just 10 years ago failed to find any size differences in the immigrant flies, which means that natural selection is not only at work, but working at breathtaking speed. ■

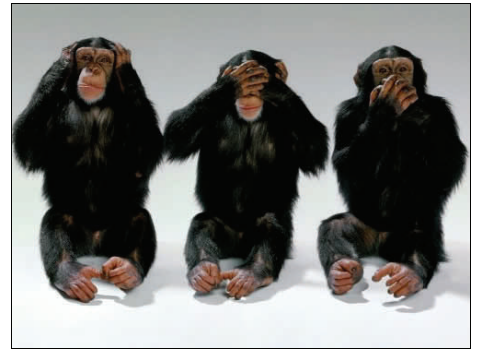

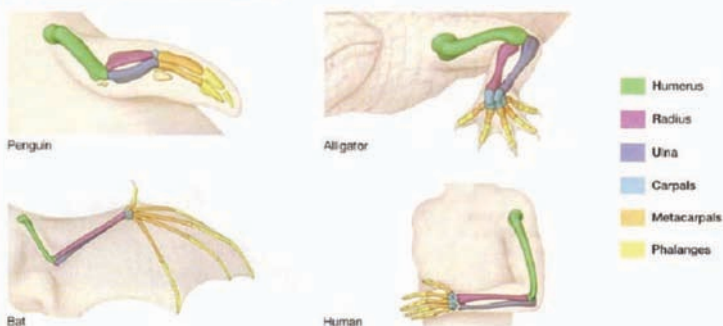
Figure 10 A bird's wing, dolphin's flipper, and dog's leg are all adapted to performing different tasks. However, the structure of the bones in each forelimb is very similar. In the diagrams, color shows which bones are homologous. These homologous structures provide evidence that these animals evolved from a common ancestor.

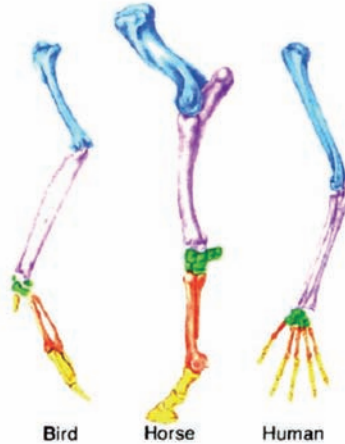
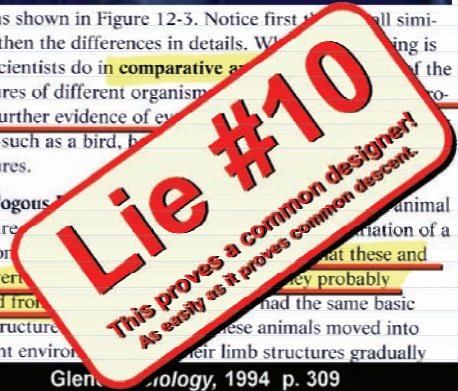


Figure 12-3 Compare the forelimbs of a bird, a horse, and a human. The bones are colored to show which ones are homologous.

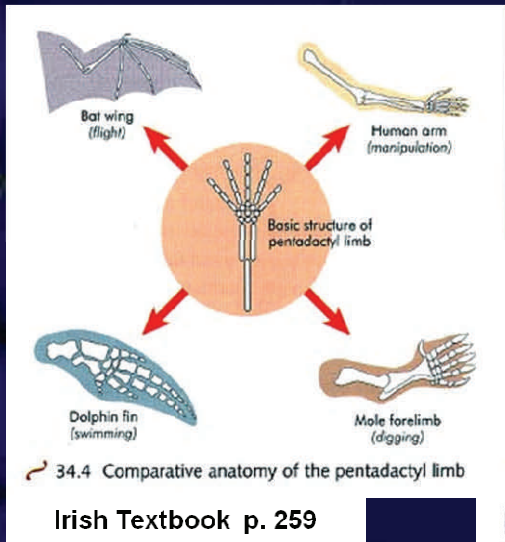

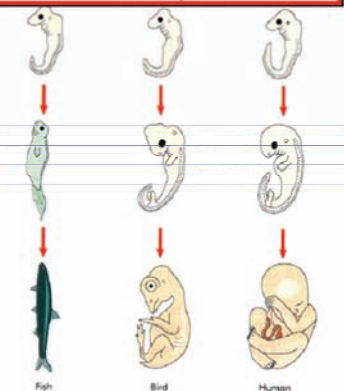
Embryology is the study of embryos. The study of the embryos of vertebrates (animals with backbones) shows that their embryos closely resemble each other, even though the adult animals may show large differences.

For example all vertebrate embryos (including humans) possess the following fishlike structures at some stage of their development: gill slits, a tail and a two chambered heart (with no septum).

It is as if the embryo retains a 'memory' of its origins and starts to copy them during its development. These structures persist in adult fish but are absent from other adult vertebrates (although the Eustachian tube in humans is the remains of the gill slits).

The presence of these fish-like structures in embryos of different species shows that these animals have evolved from fish and share the basic pattern of fish development.

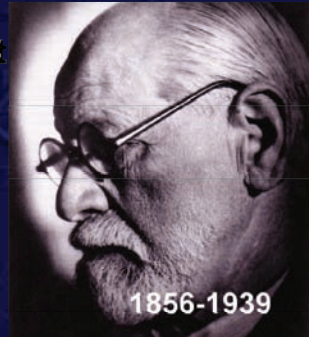

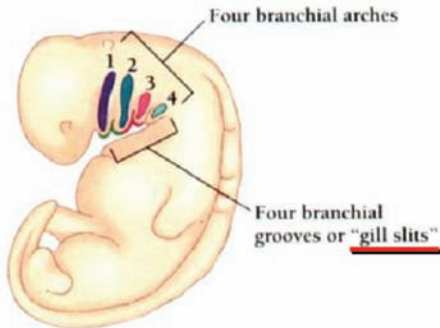

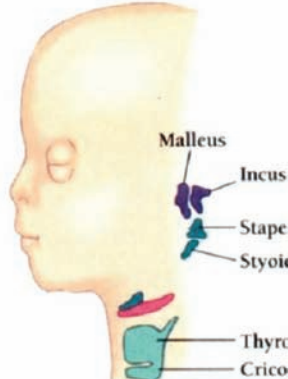
Evidence for evolution has come from studying the embryos of organisms of different species. In early stages, it's difficult to tell the difference between the embryo of a reptile (left) and a human (right) by looking at them. The embryos of these animals have tails as during periods in their evolution. In fact, at some point in their development, both of these animals have gill slits. These features that are common to both animals probably shared a common ancestor in geologic history.

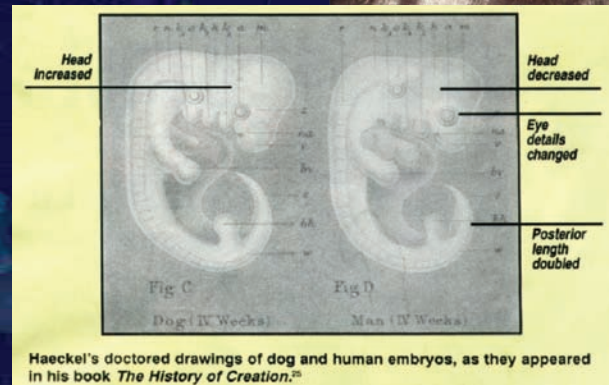

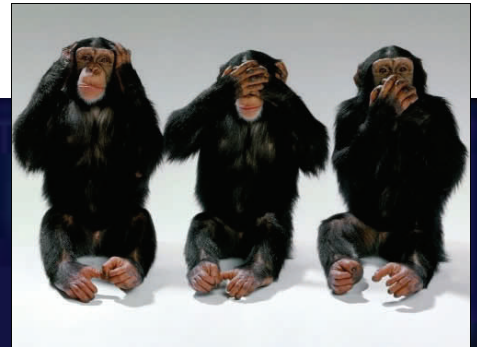

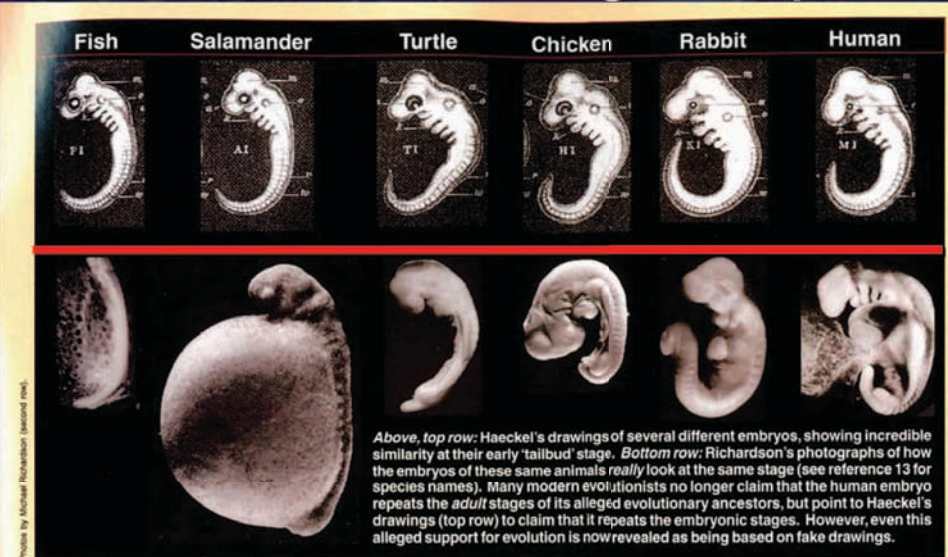

What few people know: the pictures were fakes. The deceit was exposed in *Haeckel's Frauds and Forgeries* (1915), a book by J. Assmuth and Ernest R. Hull. They quoted nineteen leading authorities of the day. Anatomist F. Kelbel of Freiburg University said that "it clearly appears that Haeckel has in many cases freely invented embryos, or reproduced the illustrations given by others in a substantially changed form."33 Zoologist L. Rüttimeyer of Basle University called the distorted drawings "a sin against scientific truthfulness."34

Despite the early exposure, Western educators continued using Haeckel's pictures for decades as proof of the theory of evolution. The matter has been settled with finality by Dr. Michael Richardson, an embryologist at St. George's Medical School, London. He found there was no record that anyone ever actually checked Haeckel's claims by systematically comparing human and other fetuses during development. He assembled a scientific team that did just that—photographing the growing embryos of 39 different species. In a 1997 interview in London's *The Times*, Dr. Richardson stated: "This is one of the worst cases of scientific fraud. It's shocking to find that somebody one thought was a great scientist was deliberately misleading. It makes me angry. . . . What he [Haeckel] did was to take a human embryo and copy it, pretending that the salamander and the pig and all the others looked the same at the same stage of development. They don't. . . . These are fakes."35

Today, though to a lesser extent, Haeckel's drawings still appear in a number of high school and college textbooks. *The Case Against Darwin*

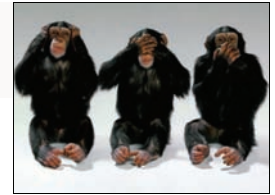

Embryonic Development
Relationships among animals can also be seen by comparing their development before birth. Most multicellular organisms such as humans, begin as a single cell called a zygote. When the egg is fertilized, it begins to rapidly, forming a ball of cells and then an embryo. The embryo changes shape gradually as it develops. Eventually, it takes the basic shape of its parents.

Note that the chicken embryo and the human embryo are similar in appearance. This indicates that chickens and humans have a more recent common evolutionary ancestor than do fish and chickens or fish and humans.

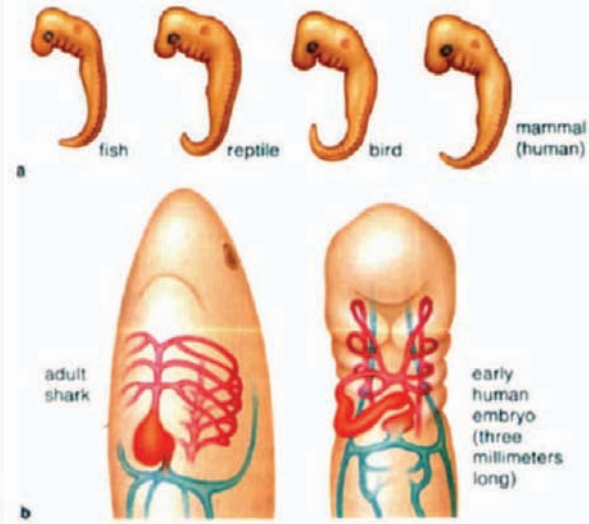
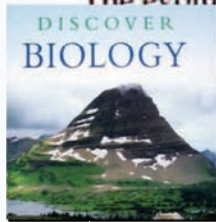


Figure 18.7 From comparative embryology, some evidence of evolutionary relationship among vertebrates.

In general, why do the embryos of organisms as different as humans and fish look alike? These and many other similarities in patterns of development are caused by common descent: Anteater and whale embryos have teeth because anteaters and whales evolved from organisms with teeth. Similarly, human and fish embryos resemble each other because humans and fish share a common ancestor.

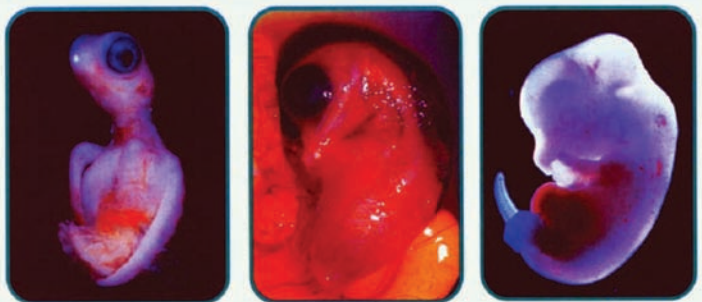


Figure 11 Turtles (left), chickens (center), and rats (right) look similar during the earliest stages of development. These similarities provide evidence that these three animals evolved from a common ancestor.

The pelvic bones found in modern whales are homologous to the pelvises that are found in land vertebrates. Although the whale pelvis bones are located near their reproductive organs, these bones do not function like a pelvis in a land vertebrate. The whale pelvis is located far from the vertebrae and has no apparent function. Thus the whale pelvis is a vestigial structure.

The evolutionary history of organisms is also seen in the development of embryos. Compare the development of a human embryo with that of the other vertebrate embryos shown in **Figure 13-14**. Each embryo develops a tail, buds that become limbs, and pharyngeal (*fair IHN jee uhl*) pouches (which contain the gills of fish and amphibians). The tail remains in most adult vertebrates. Although the structures develop at different rates in different groups of vertebrates, they are homologous. Only adult fish and immature amphibians retain pharyngeal pouches. In humans, the tail disappears by the time of birth, and pharyngeal pouches develop into other structures.

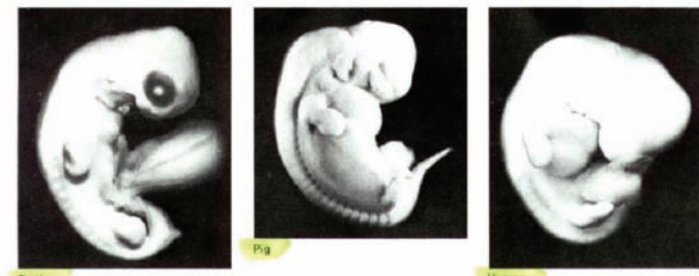
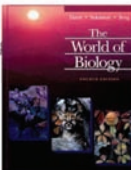


FIGURE 17-10 The early stages of embryonic development in several vertebrates. Numerous structural similarities are shared in the early stages, including the presence of a tail and gill pouches. (Robert Pugh)

Homologous structures not present in adult organisms often *do* appear in some form during embryonic development. Species that bear little resemblance to each other in their adult forms may have strikingly similar embryonic stages. In some ways, it is almost as if the embryo passes through many evolutionary stages to produce the mature organism. For example, for a large portion of its development, the human embryo possesses a tail, much like those of our close primate relatives. This tail is usually reabsorbed before birth, but occasionally children are born with the ancestral structure intact. Even though they are not generally present in the adult organism, tails could be considered homologous traits between humans and primates.
In general, the more closely related two species are, the more their embryological processes of development resemble one another.

- Rabbits did not exist in Australia until introduced by humans. A native Australian wallaby resembles a rabbit both in structure and habit. As similar as these two animals appear, they are not that closely related. The rabbit is a placental mammal, while the wallaby is a marsupial mammal. 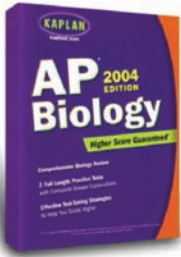

Comparative Embryology

Close study of different organisms' embryonic development can tell us much about their evolutionary ancestry. For example, the embryonic development of humans resembles the embryonic development of other vertebrates, suggesting a common ancestry and developmental history. The human embryo develops gill slits, suggesting a relation to the fishes and other vertebrates, but in humans the gill slits evolve later in development and perform other functions. Sea squirt (tunicate) larvae and amphibian embryos both have a notochord that the adults lack, indicating they are both members of the chordate phylum derived from a common ancestor. The earlier the stage at which embryonic development begins to diverge, the more dissimilar the mature organisms are. For example, it is difficult to differentiate between the embryo of a human and that of an ape until relatively late in development. Other related animals diverge soon after the early cell cleavages following fertilization. Other embryonic evidence of evolution includes such characteristics as teeth in an avian embryo (recalling the reptile stage); the resemblance of the larvae of some mollusks (shellfish) to annelids (segmented worms); and the tail of the human embryo (indicating relationships to other mammals).

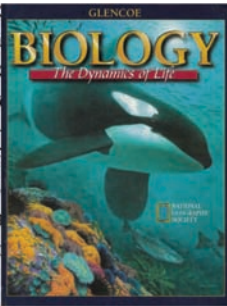


Molecular Evolution

Most organisms have the same basic needs and share the same metabolic processes. They require the same nutrients and contain similar organelles and energy storage forms (ATP). The energy-producing pathway glycolysis, for example, evolved early in the history of life and is basically the same in most organisms. The closer the organisms are in an evolutionary sense, the greater the similarity of their genetic information. The large ribosomal RNA has been conserved enough that it can be used to compare eubacteria, archaeobacteria and eukaryotes to determine their evolutionary relationship. Protein-coding genes from different organisms can be compared for the same purpose. The more similar the genetic sequences are, the more closely related the animals are. Proteins with rigid structural requirements can't change over time. Some changes, however, have an effect on the function of a certain

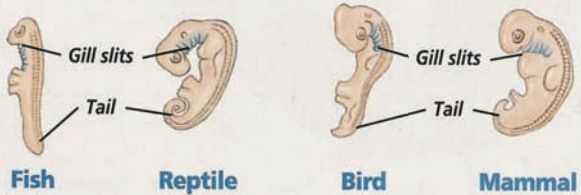

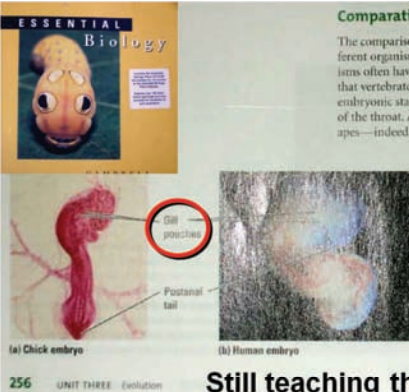

Comparative Embryology

The comparison of structures that appear during the development of different organisms is called comparative embryology. Closely related organisms often have similar stages in their embryonic development. One sign that vertebrates evolved from a common ancestor is that all of them have an embryonic stage in which structures called gill pouches appear on the sides of the throat. At this stage, the embryos of fishes, frogs, snakes, birds, apes—indeed, all vertebrates—look more alike than different (Figure 12.9).

The different classes of vertebrates take on more and more distinctive features as development progresses. In fishes, for example, most of the gill pouches develop into gills. In land vertebrates, however, these embryonic features develop into other kinds of structures, such as bones of the skull, bones supporting the tongue, and the voice box of mammals.

Figure 12.9 Evolutionary signs from comparative embryology. At this early stage of development, the kinship of vertebrates is unmistakable. Anatomy and Development

Comparisons of the anatomy of different types of organisms often reveal basic similarities in body structures even though the structure's functions may differ between organisms. For example, sometimes bones are present in an organism but are reduced in size and either have no use or have a less important function than they do in other, related organisms. Such structures, which are considered to be evidence of an organism's evolutionary past, are called **vestigial** (*vehs TII ee uhl*) structures. For example, the hind limbs of whales are vestigial structures.

As different groups of vertebrates evolved, their bodies evolved

1. There are no vestigial organs.
2. Even if there were some, that would be the **opposite** of evolution.

Millions of years ago, dolphins had legs. If you look closely at a dolphin's skeleton (below), you'll see two small rod-shaped pelvic bones. These bones may be leftover hind legs that some scientists think mean the dolphin's ancestors walked around on land. They say dolphin ancestors looked like wolves but were more closely related to modern-day cows.

DOLPHIN SKELETON

A whale's penis may be 15 feet long and weigh 300 pounds. Since they have no arms or ability to speak and mate in the dark under water both male and female whales must be able to maneuver their reproductive organs with special muscles attached to these bones.

Whales are thought to have evolved from an ancestral line of four-legged mammals, which are represented here by their fossils and artistic reconstructions showing what scientists think they may have looked like.



Mesonychians are one hypothetical link between modern whales and certain hoofed mammals. They were about 2 m (6 ft) long. They are thought to have lived about 40 million years ago. Some scientists favor an alternative hypothesis linking whales to other terrestrial mammals. These recent mammals are also considered to have lived about 40 million years ago.

Ambulocetus natans apparently walked on land like modern sea lions and swam by flapping its backbone and paddling with its hind limbs (as do modern otters). They were about 2 m (6 ft) long. They existed about 40 million years ago.

"The animal's rear legs are shown not with feet that would help it to walk, but as fins that would assist it to swim. However, Carroll, who examines the animal's leg bones, says that it possessed the ability to move powerfully on land."

"In order to present an impression of adaptation for water, webbing has been drawn on its front feet. Yet it is impossible to draw any such conclusion from a study of Ambulocetus fossils. In the fossil record it is next to impossible to find soft tissues such as these. So reconstructions based on features beyond those of the skeleton are always speculative. That offers evolutionists a wide-ranging empty space of speculation to use their propaganda tools."

Many crucial structures were not present in the Ambulocetus findings such as the pelvic girdle, the humerus and the scapula were also missing from the creature.

The backbone of the quadrupedal mammal Ambulocetus ends at the pelvis, and powerful rear legs then extend from it. This is typical land mammal anatomy. In whales, however, the backbone goes right down to the tail, and there is no pelvic bone at all. In fact, **Basilosaurus**, believed to have lived some 10 million years after Ambulocetus, possesses the latter anatomy. In other words, it is a typical whale. There is no transitional form between Ambulocetus, a typical land mammal, and Basilosaurus, a typical whale."

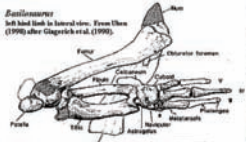
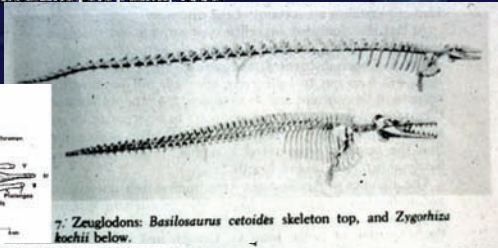

The above information was supposedly just what evolutionary naturalists needed for their tetrapod-to-whale transition, that is until the Jan. 1999 issue of Scientific American (pp. 29-30). Thewissen is quoted. Another recent article (Nature, v 406) by T. Gura states that **"evolutionary trees constructed by studying biological molecules often don't resemble those drawn up from morphology."** "Perhaps the most intense are in vertebrate systematics ... take the debate over the origin of whales ... morphologists have classified the cetaceans and mesonychids together as a sister group to the Artiodactyla. But that view came under fire when molecular evidence entered the arena." The molecular data, "suggests that the Artiodactyla, as currently defined, is not a taxonomic group. 'The molecular data say that artiodactyls, as traditionally recognized, go into the wastebasket,' says Z. Lou, a paleontologist at the Carnegie Museum of Natural History."

Thewissen, Hussain & Arif ('Fossil evidence for the origin of aquatic locomotion in Archaeocete whales' v. 263) and shows 2 reconstructions of Ambulocetus natans, an alleged fossil "whale" from Pakistan. One picture in the article shows it standing & the other at the end of a swimming stroke. It weighed about 650 lbs - about the size of a full sea lion. A preserved tail vertebra is elongated that may mean the creature retained the thin, long mammalian tail. **NO PELVIC BONES WERE FOUND** and "little is known about the tail" - **but the authors are certain the feet were enormous.** The authors conclude, "Like modern cetaceans - it swam by moving its spine up and down, but like seals, the main propulsive surface was provided by its feet. As such, Ambulocetus represents a critical intermediate between land mammals & marine cetaceans."

The rapidly growing molecular database should, in theory, complement anatomical evidence from the spectacular fossil discoveries of the past 15 yrs. Unfortunately, recent phylogenetic analyses show more conflict than compromise between molecules and morphology." - J. Gatesy, 'The Emergence of Whales' Plenum Press, 1998, p. 63.

G.A. Mchedlidze, a Russian expert on whales, has serious doubts that A. natans (or Pakicetus, "the oldest cetacean" according to Thewissen), and others - even if accepted as aquatic mammals - can properly be considered ancestors of modern whales. He sees them instead as a completely isolated group [G.A. Mchedlidze, 'General Features of the Paleobiological Evolution of Cetacea' translated from Russian, Rotterdam: A.A. Balkema, 1986, p. 91].

If this Science article (v 263) is such a landfall for evolutionism, why did evolutionist J. Whitfield GIBBONS of the U. of GA state, "Nevertheless, the evolutionary origin of whales remains controversial among zoologists" - three years later?

Please be sure your friend understands the scientific arguments against Basilosaurus being an intermediate, according to secular scientist & anti-creation author, Barbara STAHL. This is important because Basilosaurus is a critical link, who, according to S.J. Gould, "already crossed the bridge" between water & land.

Nature magazine (v 361, p. 445) states, "Cetaceans probably originated from extinct mesonychid condylarths [quoting Van Valen, 1966]." However, Carroll said in his 1997 book (p. 329), "[i]t is not possible to i.d. a sequence of mesonychids leading directly to whales [Cetacea]."

Dr. M. Denton has a unique perspective of ungulate-to-whale transition on pp. 172-75 of his 1985 book. Must reading.

A recent book, 'Darwin's God' by C.G. Hunter (2001) has a good overview of the amazing changes that had to take place in such a short period (p. 76). Short period indeed. After the dinosaurs died out, whales had to evolve with astonishing rapidity. One quick example not mentioned by Hunter are the numerous individual countercurrent heat exchangers found throughout the massive tongue of gray whales. The exchangers converge at the base of the tongue to form a bilateral pair of retia (Heyning & Mead, Science v 278). Creation scientists say these heat exchangers were designed to substantially reduce heat loss when these whales feed in cold waters. Macroevolutionists say they just evolved in at most 5 - 10 million years. If these exchangers did evolve, natural selection had nothing to do with it, "Natural selection can act only on those biologic properties that already exist [creation]; it cannot create properties in order to meet adaptational needs [evolutionism]" - Noble, Noble, Scad & MacInnes, Parasitology, 6th ed. p. 516 (the 4 authors were speaking of n/s in general).

Such increasing evidence against "whale evolution" causes me to conclude that sequences proposed by Thewissen, Gould and other evolutionists are anomalous - the forcing of data through a speculative & imaginative matching process - not representative.

Batesian mimicry - William Bateson was a leading (macro)mutationist as well as an outstanding geneticist (I believe he was the one that coined the term "allelomorph" - later shorten to "allele").

Such mimicry is a type of animal defense against predators, and, as far as I can tell has nothing to do with macroevolution. A harmless or palatable species mimics an unpalatable or harmful model - three examples are seen in the larva of the hawkmoth, Jordan's salamander, and a harmless moth & golden paper wasp. Villet, Slomon & Davis (1985) say that, "Natural selection has maintained a resemblance that gives its possessor almost as much protection as the model . . ."

"Whale Evolution"? - the eyes don't have it

Researchers from Sweden & Germany found 14 species of toothed whales & seals all lacked pigments found in blue color receptors of the eye. "However, they found the pigments in river otters and wolves, close relatives of seals, and in the hippopotamus, which is closely related to whales why this happened is a mystery other specialists in color vision are also puzzled."

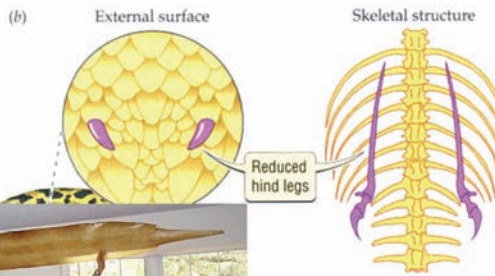
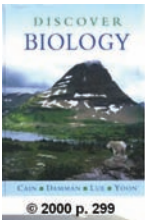
Vestigial Structures

Vestigial structures also give evidence for evolution. A vestigial (veh STIHJ ee ul) structure is a body part that doesn't seem to have a function. For example, manatees no longer have back legs, but they still have pelvic bones. Scientists hypothesize that vestigial structures are parts that once functioned in an ancestor, as seen in Figure 20-13.

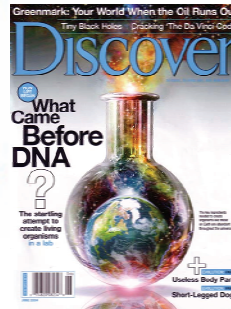

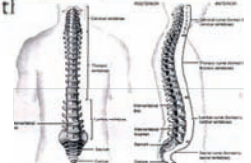

Vestigial Organs

Some organisms have structures or organs that seem to serve no useful function. For example, humans have a **tailbone** at the end of the spine that is of **no apparent use**. Some snakes have tiny pelvic bones and limb bones, and some cave-dwelling salamanders have eyes even though members of the species are completely blind. Such seemingly functionless parts are called **vestigial (veh-STIJ-ul)** organs or structures. Vestigial organs are often homologous to organs that are useful in other species. The vestigial tailbone in humans is homologous to the functional tail of other primates. Thus vestigial structures can be viewed as evidence for evolution: organisms having vestigial structures probably share a common ancestry with organisms in which the structure is functional.



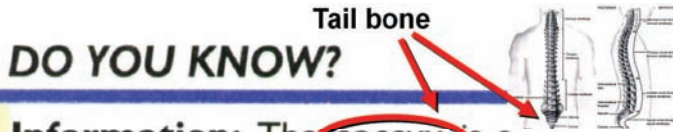

The Impact of Evolutionary Thought

Before the concept of evolution was developed, adaptations were taken as evidence for the existence of a creator. The clear examples of organisms that seem well designed for their environments implied to many people that there must be a supernatural designer—a God—much as the existence of a watch implies the existence of a watchmaker. In addition, there was a long tradition, dating from Plato, Aristotle, and other Greek philosophers, in which species were viewed as unchanging through time. Darwinian evolution shook these ideas to their very foundation: No longer could species be viewed as unchanging, nor could apparent design in nature be offered as logical proof that God existed, since evolution by natural selection provided an alternative, scientific explanation for the design of organisms.

The evolution of species and, even more, the argument that the design of organisms could be explained by natural selection, were radical ideas in the mid-nineteenth century. These ideas not only revolutionized biology, but they had a large impact on other fields, ranging from poetry to psychology to economics.

The idea of Darwinian evolution also had a large impact on religion. Evolution was viewed initially as a direct attack on Judeo-Christian religion, and this presumed attack in turn prompted a spirited counterattack by many prominent members of the clergy. Today, however, most religious leaders and most scientists do not view evolution and religion as incompatible (but see the Box on this page). For example, in a letter transmitted to the Pontifical Academy of Sciences in 1996, Pope John Paul II reaffirmed that evolution has occurred. For their part, most scientists recognize that religious beliefs are up to the individual, and that science cannot answer questions regarding the existence of God or other matters of religious import.

The emergence of evolutionary thought has also had a great impact on applied aspects of human society. For example, an understanding of evolution has proven essential when farmers and researchers have sought to prevent or slow insects and vermin to pesticides. In business, evolutionary relationships used to increase the efficacy of antibiotics and other pharmaceuticals, and many other v

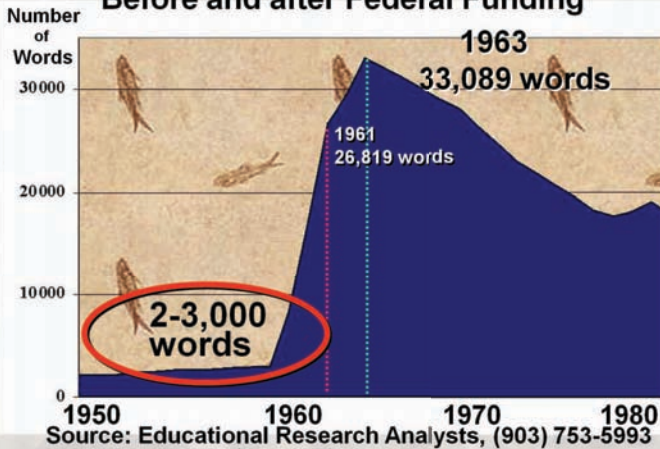

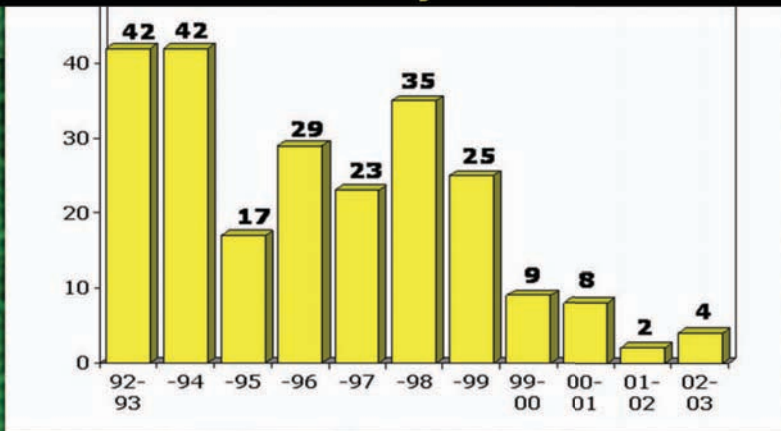

At the beginning of white settlement, there were an estimated 300,000 Aborigines settled all over Australia (Hughes 1987:9, Attenbrow 1992:3). Aborigines were viewed by the settlers as primitive, savage and unchanging. In addition to warfare killings, water, flour and sugar were poisoned and diseases (smallpox, measles and influenza) were introduced (Attenbrow 1992:11).

Aboriginal destruction was reasoned to be **natural law**, as shown in this comment from a settler in 1849: "Nothing can stay the dying away of the Aboriginal race, which Providence has only allowed to hold the land until replaced by a **finer race**" (Hughes 1987:7). Upwards of 20,000 to 25,000 Aborigines were killed prior to 1930 (Hughes 1987:277; Sutton 1988:8). Of the two-hundred and fifty languages present before 1788, now only about twenty or thirty are still spoken (Dixon 1989:7). In **Tasmania** (an island off the south of Australia), marshal law was declared to solve "the black problem" and **every single native inhabitant was slaughtered**, with the last women dying in 1876 (Hughes 1987:420-24).

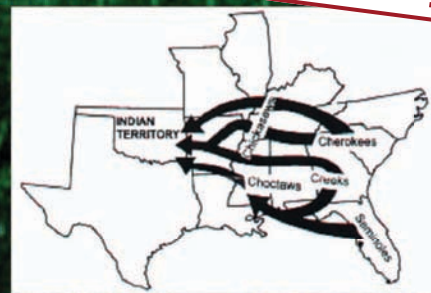
Consider this opinion:

I wish very much that the wrong people could be prevented entirely from breeding; and when the evil nature of these people is sufficiently flagrant, this should be done. Criminals should be sterilized and feeble-minded persons forbidden to leave offspring behind them. . . . The emphasis should be laid on getting desirable [sic] people to breed.*

This statement was not made by a Nazi in the 1930s but in 1913 by the American patriot Theodore Roosevelt. Although he was a great leader in other ways, he, with most of the American upper class of the early 1900s, thought that the many immigrants from Europe, Scotland, Ireland, and the Orient were a threat to American society.

As early as 1869, a group of 91 American men and women signed a pledge to participate in

The Barmen Declaration, published by the German “Confessing Church” in 1934. Loyalty to Christ was being challenged in Germany as never before. The church was being asked to recognize the events of 1933 as ordained by God and as rightly demanding obedience side by side with Scripture.

The Barmen Declaration

In view of the errors of the “German Christians” and of the present Reich Church Administration, which are ravaging the Church and at the same time also shattering the unity of the German Evangelical Church, we confess the following evangelical truths:

1. “I am the Way and the Truth and the Life; no one comes to the Father except through me.” *John 14:6* “Very truly, I tell you, anyone who does not enter the sheepfold through the gate but climbs in by another way is a thief and a bandit. I am the gate. Whoever enters by me will be saved.” *John 10:1,9* Jesus Christ, as he is attested to us in Holy Scripture, is the one Word of God whom we have to hear, and whom we have to trust and obey in life and in death. We reject the false doctrine that the Church could and should recognize as a source of its proclamation, beyond and besides this one Word of God, yet other events, powers, historic figures and truths as God’s revelation.

2. “Jesus Christ has been made wisdom and righteousness and sanctification and redemption for us by God.” *1 Cor. 1:30* As Jesus Christ is God’s comforting pronouncement of the forgiveness of all our sins, so, with equal seriousness, he is also God’s vigorous announcement of his claim upon our whole life. Through him there comes to us joyful liberation from the godless ties of this world for free, grateful service to his creatures. We reject the false doctrine that there could be areas of our life in which we would not belong to Jesus Christ but to other lords, areas in which we would not need justification and sanctification through him.

3. "Let us, however, speak the truth in love, and in every respect grow into him who is the head, into Christ, from whom the whole body is joined together." *Eph. 4:15-16* The Christian Church is the community of brethren in which, in Word and Sacrament, through the Holy Spirit, Jesus Christ acts in the present as Lord. With both its faith and its obedience, with both its message and its order, it has to testify in the midst of the sinful world, as the Church of pardoned sinners, that it belongs to him alone and lives and may live by his comfort and under his direction alone, in expectation of his appearing. We reject the false doctrine that the Church could have permission to hand over the form of its message and of its order to whatever it itself might wish or to the vicissitudes of the prevailing ideological and political convictions of the day.

4. "You know that the rulers of the Gentiles lord it over them, and their great ones are tyrants over them. It will not be so among you; but whoever wishes to have authority over you must be your servant." *Matt. 20:25-26* The various offices in the Church do not provide a basis for some to exercise authority over others but for the ministry [lit., "service"] with which the whole community has been entrusted and charged to be carried out. We reject the false doctrine that, apart from this ministry, the Church could, and could have permission to, give itself or allow itself to be given special leaders [Führer] vested with ruling authority.

5. "Fear God. Honor the Emperor." *1 Pet. 2:17* Scripture tells us that by divine appointment the State, in this still unredeemed world in which also the Church is situated, has the task of maintaining justice and peace, so far as human discernment and human ability make this possible, by means of the threat and use of force. The Church acknowledges with gratitude and reverence toward God the benefit of this, his appointment. It draws attention to God's Dominion [Reich], God's commandment and justice, and with these the responsibility of those who rule and those who are ruled. It trusts and obeys the power of the Word, by which God upholds all things. We reject the false doctrine that beyond its special commission the State should and could become the sole and total order of human life and so fulfill the vocation of the Church as well. We reject the false doctrine that beyond its special commission the Church should and could take on the nature, tasks and dignity which belong to the State and thus become itself an organ of the State.

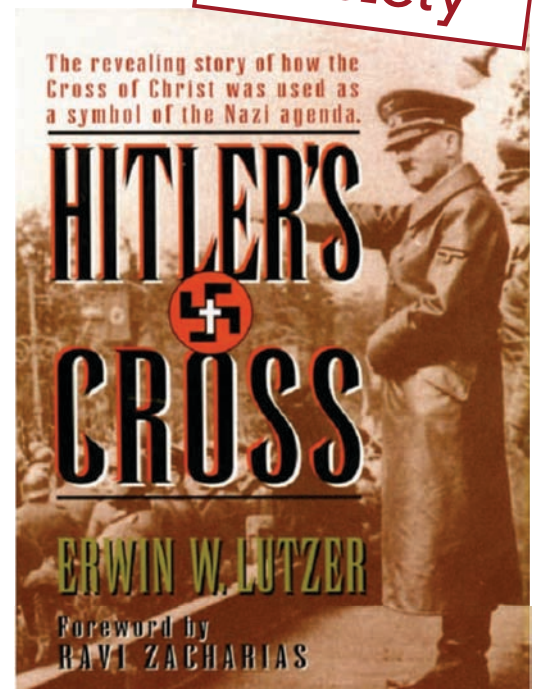
6. "See, I am with you always, to the end of the age." *Matt. 28:20* "God's Word is not fettered." *2 Tim. 2:9* The Church's commission, which is the foundation of its freedom, consists in this: in Christ's stead, and so in the service of his own Word and work, to deliver all people, through preaching and sacrament, the message of the free grace of God. We reject the false doctrine that with human vainglory the Church could place the Word and work of the Lord in the service of self-chosen desires, purposes and plans. The Confessing Synod of the German Evangelical Church declares that it sees in the acknowledgment of these truths and in the rejection of these errors the indispensable theological basis of the German Evangelical Church as a confederation of Confessing Churches. It calls upon all who can stand in solidarity with its Declaration to be mindful of these theological findings in all their decisions concerning Church and State. It appeals to all concerned to return to unity in faith, hope and love.

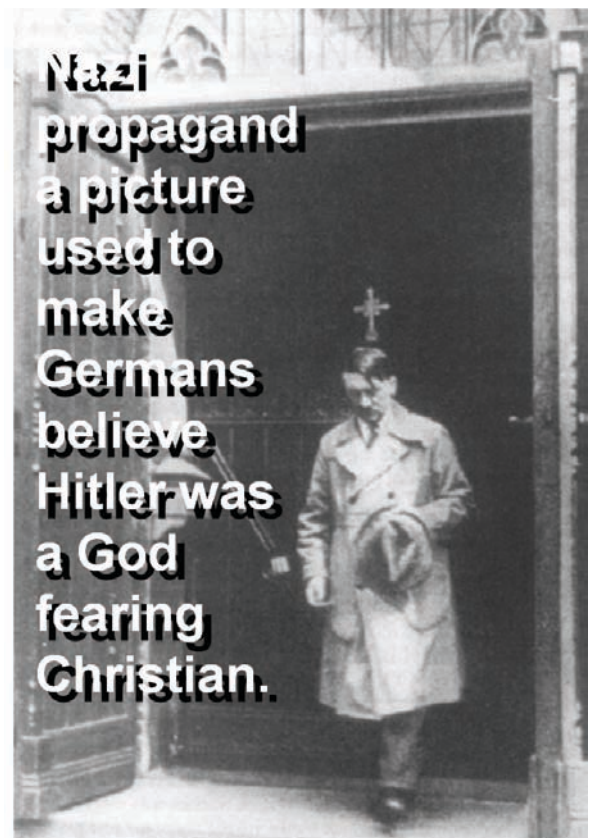

This notion the Confessing Church rejected. The second article makes this even clearer. One cannot be equally loyal to the *Volk* and to the state. By exalting the idea of the *Volk* into a divine ordinance, the German Christians gave to it the nature of revelation. This, too, was unequivocally rejected at Barmen. One of the most important theological contributions to the development of the German Christian movement was that of Emanuel Hirsch, who sought to inspire a new national pride after the debacle of 1918. He maintained that the interests of the individual should always be kept subordinate to those of the nation. In his book *Deutschlands Schicksal, Staat, Volk und Menschheit im Lichte einer ethischen Geschichtsansicht* (published in 1921) Hirsch set out the foundation of a social revolution in which *Volk* and nation are acknowledged as part of God's will in creation, and he sought to establish a national *Volks*-state as a boundary established by God. In this state the individual conscience is swallowed up by the *Volk* conscience, and the duty of the individual is identified with the duty of the whole people. In his book *Die Liebe zum Vaterland* (published in 1924) Hirsch delineated the moral demands of the nation-state. Because *Volkheit* is a principle of God's creation, obedience to it is not obedience to an earthly order but obedience to the eternal. Later, when he published his lectures in 1934, he acknowledged in Hitler's National Socialism the power of leadership that would rectify all the mistakes of past German history.

I believe the day is coming – perhaps it is already upon us – when American believers will be forced to see in the cause of the Confessing Church in Germany their own cause as well. Principled conservatives who rightly fear the power of unrestricted government have much to learn from the Barmen Declaration. A modern day “American Christian” movement belligerently struts along, echoing the sophistries and fabrications of the White House and the Republican National Committee. The penal barbarism of Abu Ghraib, the doctrine of preemption, the Patriot Act's infringement on the Bill of Rights – all are glaringly Hitlerian, and stand in stark contrast to the Jeffersonian ideal, which always places individual liberty above the caprice of the state. Clinton's simian sexual behavior can't begin to compare with the crude, anti-republican ideology of George W. Bush, who sent a very Hitleresque message to the nation by hyping the fictitious “terrorist threat” posed by Iraq. Tragically, a postprandial orgy of biased reportage allows the administration's statist theology to go unchallenged. For many Americans, Bush's claims alone are “truth.”

Teddy Roosevelt once said that any American who blindly accepts everything that comes out of a president's mouth is not only wrong and servile, but unpatriotic. As Americans, we have a patriotic responsibility to speak out against the president when we think he is wrong. This is precisely what the Confessing Church in Nazi Germany tried to do. In producing the Barmen Declaration, they hoped to prick the consciences of their fellow churchmen, bring them back to their senses, and return the Body of Christ to its allegiance to Jesus Christ, the Word of God. I trust the Barmen Declaration might have the same effect when it is encountered today. Readers are reminded that this is a document written in the crucible of real life and not a systematic treatment of Christian doctrine. It is to be approached not as an intellectual exercise but as a message to the heart. Read thus, it will, I believe, speak as from the Spirit of God Himself, with challenging power.

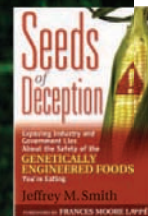


INTRODUCTION

On May 23, 2003, President Bush proposed an Initiative to End Hunger in Africa using genetically modified (GM) foods. He also blamed Europe's “unfounded, unscientific fears” of these foods for hindering efforts to end hunger. Bush was convinced that GM foods held the key to greater yields, expanded U.S. exports, and a better world. His rhetoric was not new. It had been passed down from president to president, and delivered to the American people through regular news reports and industry advertisements.

The message was part of a master plan that had been crafted by corporations determined to control the world's food supply. This was made clear at a biotech industry conference in January 1999, where a representative from Arthur Anderson Consulting Group explained how his company had helped Monsanto create that plan. First, they asked Monsanto what their ideal future looked like in fifteen to twenty years. Monsanto executives described a world with 100 percent of all commercial seeds genetically modified and patented. Anderson Consulting then worked backward from that goal, and developed the strategy and tactics to achieve it. They presented Monsanto with the steps and procedures needed to obtain a place of industry dominance in a world in which natural seeds were virtually extinct.

Integral to the plan was Monsanto's influence in government, whose role was to promote the technology worldwide and to help get the foods into the marketplace quickly, before resistance could get in the way. A biotech consultant later said, “The hope of the industry is that over time, the market is so flooded that there's nothing you can do about it. You just sort of surrender.”¹

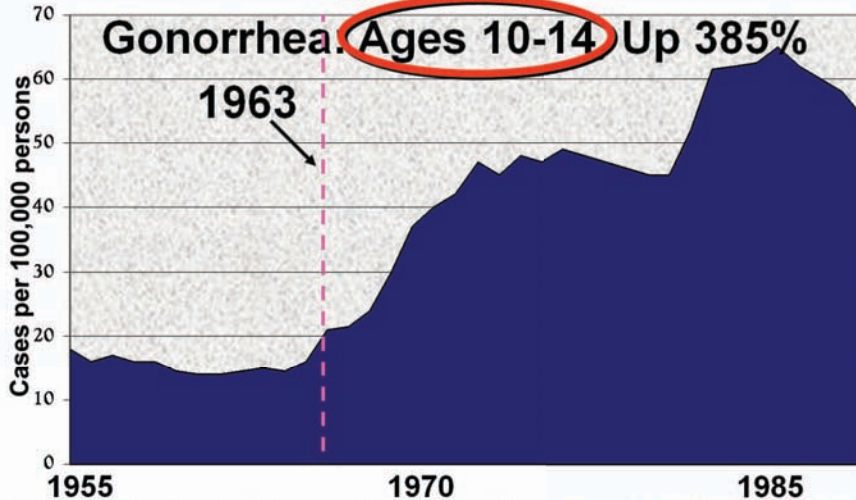
Indoctrination in Evolution Before and after Federal Funding

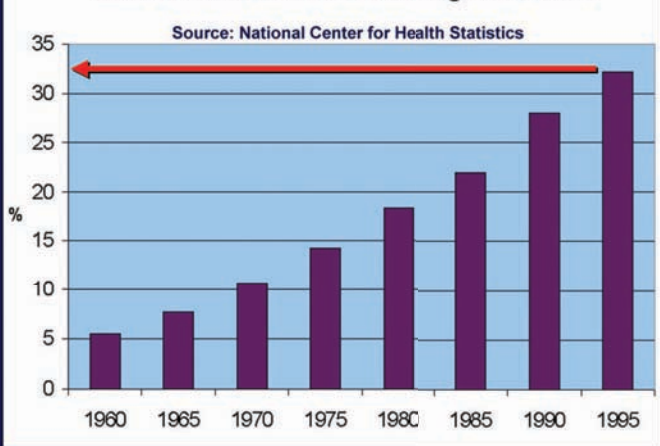

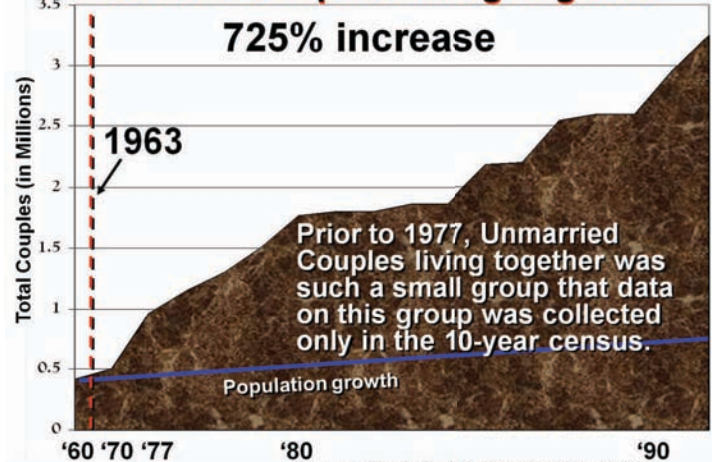

Out of Wedlock Births as a Percentage of all Births

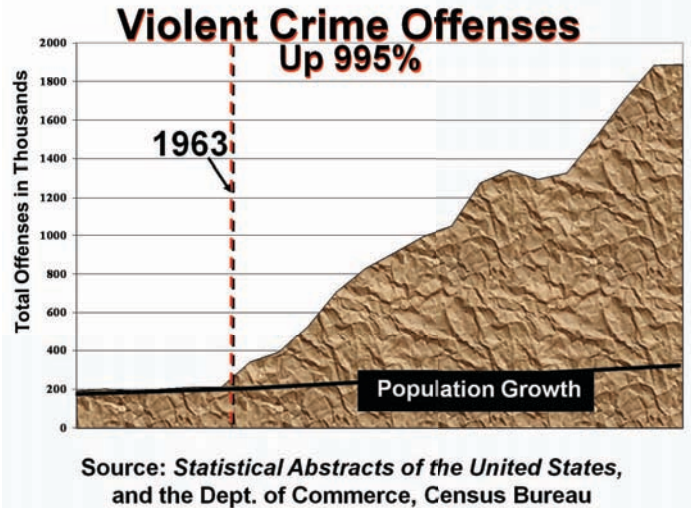
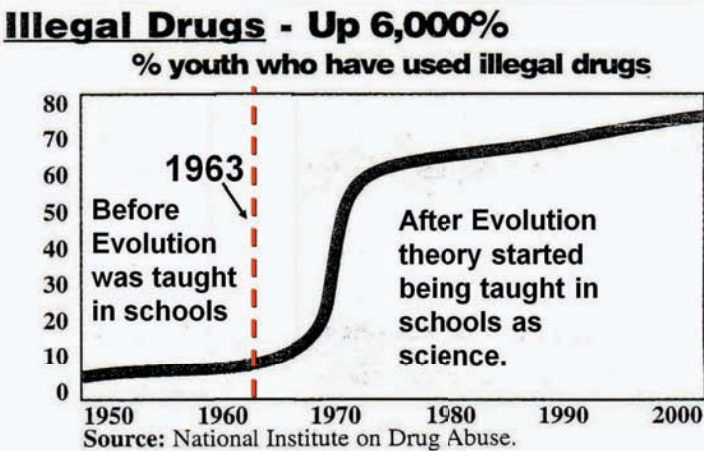
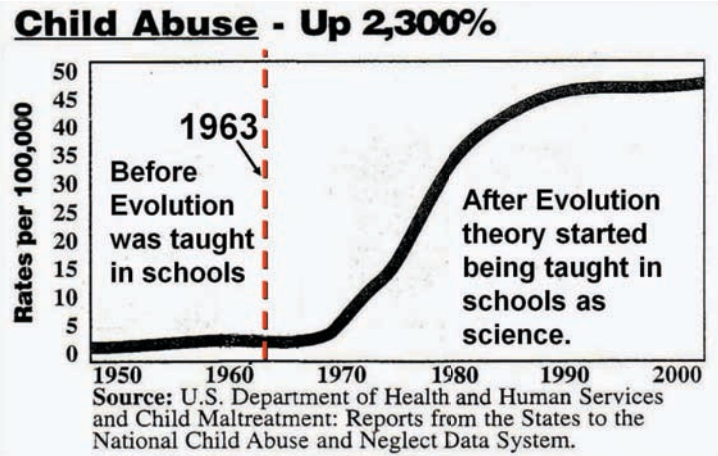
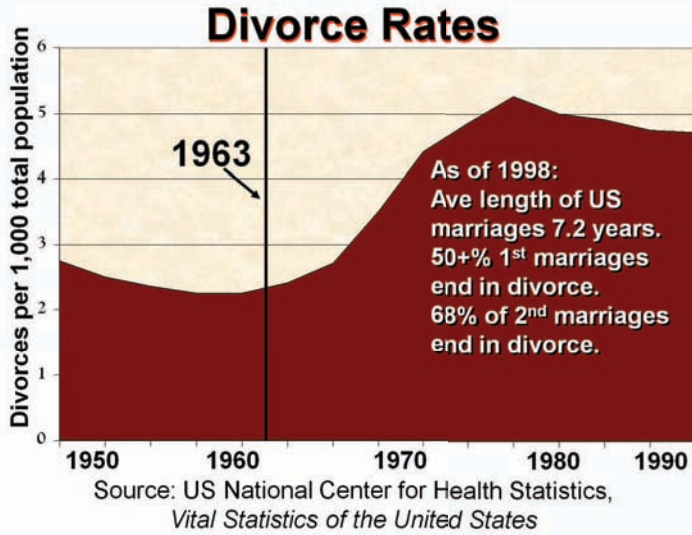

Accuracy of instructional materials.--

(1) In addition to relying on statements of publishers or manufacturers of instructional materials, the commissioner may conduct or cause to be conducted an independent investigation to determine the accuracy of state-adopted instructional materials.

(2) When errors in state-adopted materials are confirmed, the publisher of the materials shall provide to each district school board that has purchased the materials the corrections in a format approved by the commissioner.

(3) The commissioner may remove materials from the list of state-adopted materials if he or she finds that the content is in error and the publisher refuses to correct the error when notified by the department.

(4) The commissioner may remove materials from the list of state-adopted materials at the request of the publisher if, in his or her opinion, there is no material impact on the state's education goals.

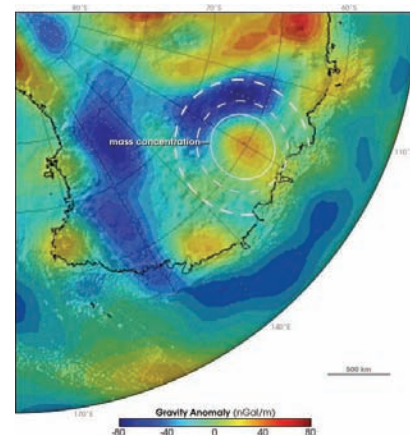
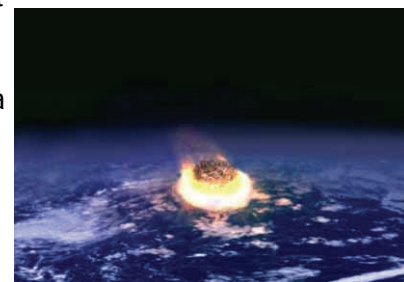
• The Flood / Cataclysm event

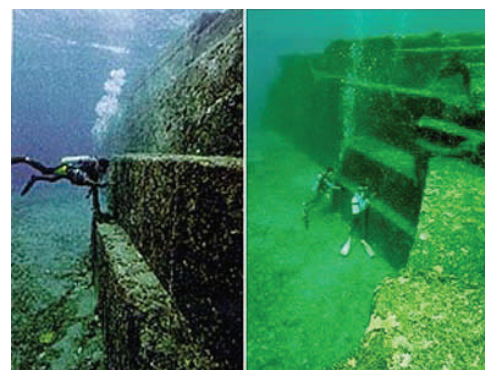
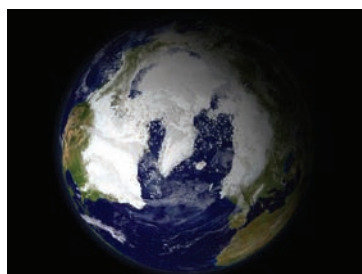
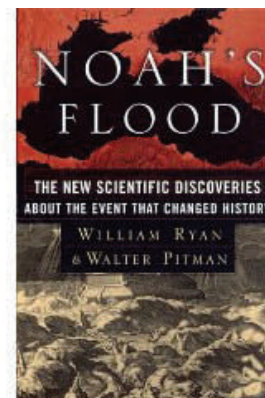
All these forces combined make a cataclysm event beyond that depicted in movies like 2012 and The Day after tomorrow. Such an event would tear vegetation from the land crating large floating mats upon which many creatures could survive and exist, large sediment deposits would be created, and over the next year's burial of animals, and some humans would occur in massive graves and scattered. Striation and filtering of materials would occur creating the coal deposits and other geologic formations we see today. Some areas of the globe would be greatly affected and a few may have been less affected. Humans being more intelligent would have been the last and fewest affected. They would have moved to higher ground, and or survived on the floating mats much longer than other creatures, being the last in many cases to be buried; fewer fossils would be preserved and found. Half-god, half-beast

Expedition set to track legendary mega-lizard

In the deepest part of Africa, many days of sweaty, insect-stinging travel by canoe up the Congo and by foot through the jungle they say an ancient beast forgotten by time still lingers through the petrified Lioanda swamps. Mokele-mbeke is said to look like a scaled-down brontosaurus, like a large lizard like a hippo or elephant, with a long neck and a long tail. The Lioanda word is variously translated as "stepper of rivers" and "half-god, half-beast." Like the dinosaur it resembles, it is said to be a vegetarian that lives in the water.

Congolese villagers and European travelers have reported mysterious, unexplained noises and claimed to see the size of dinner plates. Blurry photos of what may be large reptilian shapes exist. But like its distant spiritual cousins—the Loch Ness monster, Sasquatch and the Yeti—numerous expeditions have failed to prove Mokele-mbeke's existence. For the millionths, an Englishman

A living dinosaur?

Legend has it that a large animal resembling a sauropod dinosaur lives in the area of the Lioanda Swamps in the Republic of Congo. The creature is known as Mokele-mbeke. (pronounced "moh-ke-ey-moh-be") which in the local language translates as "one that spans the flow of rivers."

Mokele-mbeke has been described as a large animal 16 to 32 feet in length with a long neck and tail. It is also alleged that the reddish-brown to gray animal, which lives in the region's swamps and rivers, eats only vegetation.

Over the past several expeditions have been mounted to the Congo in search of the mythical creature.

In 1993, Maxwell Agnagna, a zoologist from Brazzaville, the Congo capital, snapped a fuzzy picture of a 30-foot-long beast, and offered detailed descriptions of a creature with a slender reddish snout and oval, lidless eyes, seen only 300 yards offshore at Lake Tika.

Skeptics include the explorer and writer Rudolph C. Henning, who has based swamp-sucking bees on his search for the creature five years ago.

He concluded that the sightings were of elephants feeding shores using their trunks as snorkels, or possibly swimming pythons.

Other credible sightings include reports from a German expedition in 1913 and an aerial video of disturbances in the waters of Lake Tika taken by a Japanese film crew in 1992.

Devries said, "If we do find the mokele, we will not disturb it for long. Our aim is to get an accurate description and photographs, and then press for the highest conservation."

The original world—what has changed?
